Sample Itinerary*

LATE OCTOBER, 2026

DAY 1 (D) Guests will arrive into Winnipeg by their own arrangements and check in for the evening at the Lakeview Signature by Wyndham, located at Winnipeg's international airport.

The group is invited to join their Frontiers North Interpretive Guide for a welcome dinner this evening with time to review the trip itinerary details. Overnight in Winnipeg.

DAY 2 (B,L,D) After breakfast we'll depart on an early morning flight from Winnipeg to Churchill.

Upon arrival we will set out for a Churchill and area tour taking the group to local and historical points of interest such as Cape Merry, the Port of Churchill, and Manitoba Conservation's Polar Bear Holding Facility, weather permitting.

After lunch at a local restaurant the group will visit the Itsanitaq Museum, home to one of the most extensive collections of Inuit art in the world. Marvel at the intricate carvings, hand-made kayaks and artifacts dating from pre-Dorset, Dorset, Thule, and modern Inuit times.

DAY 2, CONT'D Next, the group will make their way to the Parks Canada Visitor Centre, located in Churchill's historic train station. Guests will learn about the wonders of Wapusk National Park and the national historic sites in Northern Manitoba through interactive exhibits. Experience an in-depth presentation of the ecology and human history of Churchill with the guidance of knowledgeable Parks Canada representatives.

B, L, D: Breakfast, Lunch, Dinner

After dinner together, the group will visit the Polar Bears International (PBI) House, an innovative public space allowing visitors to learn about polar bears, polar bear conservation and research. Or, we will enjoy a cultural presentation hosted by a local indigenous resident who shares their stories of growing up in the North. Overnight in Churchill.

DAY 3 (B,L,D) Today guests will be transferred beyond the town limits to Churchill's boreal forest to enjoy an interpretive program paired with a thrilling dog sled excursion. Hosted by a local Churchill resident and dog sledding expert, guests will learn

DAY 3, CONT'D about the history associated with dog sledding as well as enjoy a mile-long ride on a custom-built sled behind a strong team of huskies.

Afterwards, transfer to the Tundra Buggy dock to board a Tundra Buggy® before making the journey to the Tundra Buggy Lodge. Meet with the Tundra Buggy Lodge staff for a safety briefing followed by a delicious meal prepared by the lodge chef. Overnight at the Tundra Buggy Lodge.

DAY 4 & 5 (B,L,D) After breakfast each morning, the group will depart for a full-day Tundra Buggy adventure exploring the Churchill Wildlife Management Area in search of polar bears, arctic fox, ptarmigan and other sub-arctic wildlife. Lunch and refreshments will be served on board.

Return to the Tundra Buggy Lodge each evening in time for cocktails and appetizers followed by an extraordinary dinner, after which guests will spend their evenings relaxing in the Thanadelthur Lounge, enjoying presentations and visiting with fellow travelers. At night, look to the skies in search of the northern lights. Overnight at the Tundra Buggy Lodge.

DAY 6 (B,L,D) Guests will bid farewell to the Tundra Buggy Lodge this morning as they embark on their third and final full-day Tundra Buggy adventure.

After a day of exploring the tundra, the group will be transferred directly to the airport for an evening flight back to Winnipeg. A light meal will be served onboard. Check in for the night at the Lakeview Signature by Wyndham, located at Winnipeg's international airport. Overnight in Winnipeg.

DAY 7 **(B)** After breakfast, guests may depart Winnipeg at their leisure.
